- Following discussion with SSSC, they can promote Learning Hub and asked SDSS to consider promoting CPL badge within resources.
- Training for Trainers YouTube playlist currently in progress of being developed.
- Training Locator user testing now complete and training providers have been approached to begin listing on the Locator.
- All aspects of work to be completed by end of March.

## PA Direct Payment National Agreement Subgroup (DMu)

Standard 13 in process of being approved by COSLA to enable publication. Guidance to accompany standard in development. Easy read version of standard now complete.

#### Wellbeing Subgroup (DMu)

- Meeting held on 27<sup>th</sup> February to establish priorities for 2025.
- Provided feedback for PAWS survey.
- Further updates to wellbeing hub resources for PAs.

#### **Recruitment Subgroup (KH)**

- My Job Scotland page has 1000+ vacancies posted and an average of 9,800 views a month. Data gap identified between how many people are clicking on ads compared to completed applications. Work underway with ISOs to address this.
- Recruitment toolkit being refined, aim to publish and share with ISOs/LAs/SiRDs in March.
